During the years in education, your school community became an extension of your family. As you begin this new chapter of life, we invite you to remain a member of this family.

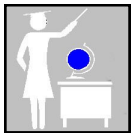
As a member of NEA/AFT and the NDU-Retired family, many of the benefits of active membership continue on in retirement.

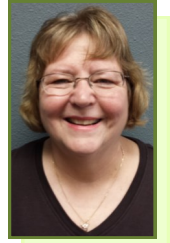
